INVESTMENT OBJECTIVE: A total return approach seeking to produce returns in varying market environments while exhibiting less downside volatility than the S&P 500.

INVESTMENT APPROACH: The Tactical ETF Strategy is a value oriented approach that identifies attractive ETFs that demonstrate a potential edge in their structure and investment thesis to hold long term. The strategy focuses on balancing a blend of diversified ETFs and can also tactically trade the SPDR S&P 500 (SPY) and the ProShares Short S&P 500 (SH). A portion of the portfolio may invest opportunistically or remain in cash. This strategy is designed for a long-term investor looking for a diversified total return strategy.

STRATEGY STRENGTHS

- Systematic approach to identify the attractive ETFs to hold long term in the portfolio.
- Flexibility to be long, short, or neutral on the market.
- Tactical approach to opportunistically capture returns in different market environments.
- Takes a neutral or cash position when no opportunity is signaled.
- Employs both fundamental and technical analysis in portfolio construction.
